Subject: Italnastrì S.r.l. announces winning the acquisition of the industrial complex previously owned by Italnastrì S.p.a. in liquidation.

On Thursday 28 June 2018, the competitive bid to acquire the industrial company located in Cerreto Guidi (Florence), Via 8 Marzo 13/15/17, took place before the Court of Florence. The transfer of the asset will take place according to the customary modalities and timing of the procedure.

The winning bidder Italnastrì S.r.l., born out of the partnership between Sherekan Group S.r.l., MS Distribution SE and Rossella S.r.l. (industrial partner and leading player in the production and sale of siliconized liners), was already a leaseholder of the business branch as of 30 October 2017.

The successful conclusion of the acquisition by the new Italnastrì S.r.l. marks the beginning of a new chapter that was already initiated eight months ago, and gives fresh impetus to the ambitious project of the new management and of the new owners, represented by the Chairman of the Board Andrea Minazzi, by Mr. Giuseppe Varlonga and by the Managing Director Dr. Karim Shahir Barzegar.

Under the leadership of the latter, Italnastrì had already embarked on a path of complete corporate restructuring, aimed at cementing its presence on the national market, reconsolidating relations with its partners (customers and suppliers) and progressively expanding its activities abroad.
